ACH ITEM POSTING CHANGES!

Effective September 15, 2017, ACH debits and credits have the ability to post on the same day they're created. This affects all financial institutions.

What Changed?

ACH debit transactions, including paper checks that are converted by payees, are posted by the credit union when they are received throughout the day.

How does this affect me?

Items may post to your account throughout the day. Also, ACH payments authorized over the phone or online, plus checks that payees convert to ACH payments, could post to your account the same day they're authorized.

Will my deposit be affected?

No. Direct deposits will continue to be credited to your account on the posting date set by the originator of the direct deposit.

Debit items could post to your account the same day they're authorized. To avoid overdrafts, funds should be in your account before you authorize any payment.
